

## APPLICATION FEE WAIVER REQUEST INSTRUCTIONS

A limited number of application fee waivers are available for applicants to Biostatistics graduate programs who are U.S. Citizens or Permanent Residents of the U.S. and meet additional eligibility criteria. The application fee waivers are available only to cover the primary application fee within the SOPHAS system; secondary application fee waivers are not available. Prospective students that do not meet eligibility criteria in these categories may request an application fee waiver with justification.

**Please note: fee waivers must be issued before submitting your application. We cannot issue reimbursements for the application fee.**

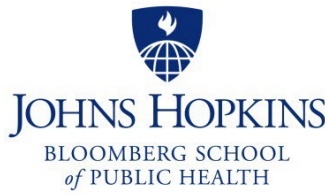
Applicants are eligible for an application fee waiver for:

- **Documented financial hardship:** Financial hardship is defined as earning less 200% the poverty level based on your household size, see <https://aspe.hhs.gov/poverty-guidelines>. Documentation may include a financial award letter from the college you currently attend or a copy of FAFSA or Student Aid Report (SAR). Please redact all social security numbers from the documentation before submitting.
- **Documentation of the following:**
  - Participation in an annual conference or workshop sponsored by a professional society, e.g. Eastern North American Region (ENAR) International Biometric Society annual conference or the Joint Statistical Meetings sponsored by the American Statistical Association
  - Participation in a Summer Institute for Biostatistics (SIBS) Program or similar summer program with scientific focus, e.g. computational biology, data science or computer science.
  - U.S. Military service
  - Attendance at a VTSI-eligible undergraduate institution ([review the list of eligible MSIs](#))
  - Application to an eligible VTSI PhD program ([review the list of eligible VTSI PhD programs](#))

Documentation may be a copy of your registration at a conference or workshop, an unofficial copy of your undergraduate transcript, or your notification of acceptance into a SIBS program.
